

ANTENA 1 (Greece) THE ENEMY WITHIN

Antena 1 (Greece) consciously promotes Turkish interests to the detriment of the Greek Cypriot victims

It has now been confirmed that the management of Antena 1 (Greece) consciously promotes the recognition of the Turkish illegal regime in occupied Cyprus in total and direct violation of Security Council Resolutions. For 37 years the Turks have been trying in vain to get their illegal entity in the occupied areas of the Republic of Cyprus recognised. The only country that recognises the illegal regime is Turkey itself, its creator. Now Antena 1 (Greece) has been “enrolled” to do the dirty work for Turkey and become the enemy within.

Reminder: Last year the Turks tried to promote recognition of the illegal regime using the Latin American actress Jennifer Lopez by inviting her to sing on the day of the barbaric invasion of Cyprus i.e. 20th July. Due to active worldwide campaigning initiated by Cyprus Action Network of America and grass-root activism, the story broke out in international newspapers starting with “The Guardian” in London. Tens of thousands of grass-root activists raised their opposition through Facebook initiatives, letter writing, faxes and emails to Lopez, as a result of which the real motives of the Turks were exposed and Jennifer Lopez cancelled her appearance in the occupied areas of Cyprus and hotels built on stolen land. (Ezel is shot in casinos and hotels built on stolen land of Voukolida village in the Karpasia area, in Kyrenia and other parts of the occupied areas).

This year the Turks changed policy. They came through a Greek channel, i.e. Antena 1 (Greece), the ENEMY WITHIN.

Antena 1 (Greece) violates UN Security Council Resolutions

The decision of this Greek TV station to broadcast this specific Turkish soap production named Ezel, shot mostly in parts of the Republic of Cyprus under Turkish invasion and ongoing occupation since 1974, the producers of which at the end of each episode thank the illegal regime for its assistance in the production, is a direct and ruthless provocation to the Greek Cypriot victims and to international law. Antena 1 (Greece) consciously contravenes and

violates the two relevant United Nations Security Council Resolutions 541/83 and 550/83. Both resolutions followed the unilateral declaration by the Turkish Cypriots of the pseudo state in 1983.

Resolution 541 of 1983 states:

“... Deplores the declaration of the Turkish Cypriot authorities of the purported secession of part of the Republic of Cyprus. Considers the declaration referred to above as legally invalid and calls for its withdrawal... Calls upon all States to respect the sovereignty, independence, territorial integrity and non-alignment of the Republic of Cyprus. Calls upon all States not to recognise any Cypriot state other than the Republic of Cyprus...”

Resolution 550 of 1983 states:

“ Having considered the situation in Cyprus at the request of the Government of the Republic of Cyprus... reaffirms its resolution 541 (1983) and calls for its urgent and effective implementation. Condemns all secessionist actions, including the purported exchange of Ambassadors between Turkey and the Turkish Cypriot leadership, declares them illegal and invalid and calls for their immediate withdrawal. Reiterates the call upon all States not to recognise the purported state of the “Turkish Republic of Northern Cyprus” set up by secessionist acts and calls upon them not to facilitate or in any way assist the aforesaid secessionist entity. Calls upon all States to respect the sovereignty... of the Republic of Cyprus”.

The evidence: The producers thank the “authorities” of the illegal entity i.e. “TRNC – Turkish Republic of Northern Cyprus” (KKTC in Turkish) i.e. the purported state the UN Security Council Resolutions call upon all States NOT to recognise, NOT to facilitate or in anyway assist the secessionist entity. Antena 1 (Greece) is doing just that regardless.

Antena 1 (Greece) - The Voice of Turkey

Antena 1 (Greece) has thus become the voice of Turkey broadcasting from Marousi Athens. In doing so however, Antena 1 (Greece) exposes also the Greek Government vis-à-vis its obligation to abide by the United Nations Security Council Resolutions 541/83 and 550/83 besides having a primary obligation (Greece) to respect the integrity of the Republic of Cyprus as one of the guarantor powers of its independence in 1960.

Demonstrations

On 1st July 2011 demonstrators protested against the promotion of Ezel, outside Antena 1 (Greece) studios in Marousi Athens. The management asked for a meeting with the protesters for Monday the 4th at 3.00pm which was accepted. On Monday they asked for postponement until Wednesday the 6th of July same time. It was accepted. On 6th July the officials behaved atrociously refusing to see the Committee of protesters and a dialogue took place... over the phone with Antena official Mr. Spilios Haramis and one Committee member Mr. N. Argyropoulos. The repeated statement by Mr. Haramis to all questions of Mr. Argyropoulos was explicit and adamant “**We will continue (promoting Ezel) and you do as you please**”.

Antena is politically motivated

By their persistence to promote Ezel no matter what, the officials of Antena 1 (Greece) have exposed themselves as politically motivated to the benefit of

Turkish interests and directly against the interests of the Republic of Cyprus and Greece itself.

Will Antena 1 (Greece) join Turkish PM Ertogan in “celebrating” the slaughter of the Greek Cypriots on 20th July 2011?

It has been announced that on 20th July, Turkish Prime Minister Ertogan will be “celebrating” the Turkish invasion of Cyprus and the slaughter of the Greek Cypriots during the bloody months of July and August 1974. He will be joining the Turkish Cypriots and his 40,000 Turkish army of occupation together with the 160,000 (minimum) Turkish Anatolian settlers purposely imported into the occupied areas in order to change the demographic character of the area, (internationally recognised as war crime), in “celebrating” the mass uprooting of 200,000 Greek Cypriots from their homes and properties, the murders of 6,000 Greek Cypriots, the rapes of well over 1000 Greek Cypriot women by the Turks, the 1619 missing presumed dead but whose whereabouts Turkey still refuses to release and the destruction, demolition and looting of well over 500 Christian Orthodox Churches and places of worship in the occupied areas.

Ezel exported only to countries under Turkish influence

According to Hurriyet newspaper, Ezel production is only exported to Turkish-speaking countries (a small number of ex Soviet Union republics such as Turkmenistan) and countries under Turkish influence i.e. Albania, Skopja and recently Bosnia and now... Greece! Greece is the only western country and a member of the European Union that imports these cheap Turkish soaps. Is Greece also under Turkish influence???
